In our goal for service excellence it has become necessary to implement the following lead times and conditions. These conditions should be read in conjunction with MESH & BAR PTY LTD TERMS AND CONDITIONS OF SALE.

**Standard Materials – Stock 6 metre Bar, Standard Mesh and Accessories**

- Subject to availability, orders for standard material placed prior to 1pm can be delivered next working day.
- Standard material that requires scheduling can be delivered the next working day once scheduling is completed. Lead times for scheduling apply.

**Scheduled Materials - Processed Bar, Mesh and Accessories**

- We require sufficient lead times to allow for scheduling, manufacturing and associated processing of material. The minimum lead times for orders are:
  - a) Footings - 5 to 7 working days
  - b) Slabs, Columns, Walls etc - 10 working days
- Customers are required to supply a delivery program and ongoing updates to ensure we can meet your delivery times. Lead times as noted above.
- Changes in details and amendments, which affect an area already scheduled, will incur an additional 3 to 10 working days depending on the extent of the changes.
- Sufficient notice shall be given for cancellation of an order. Cancellations are subject to Mesh & Bar Terms and Conditions of Sale.

**Delivery**

- Customers are advised to arrange steel deliveries one day prior to steel fixing. Mesh and Bar will not be held responsible for any back charges or issues incurred as a result of arranging delivery and fixing on the same day.
- Drivers are expected to deliver to an accessible and nominated drop off point. The driver will accommodate all reasonable requests. If they deem the request unsafe, they may refuse the request. The final decision lies with the driver as they are bound to work within Workcover safety regulations.
- Drivers will not be held liable for any damages on site if the customer has asked them to deliver to an other than nominated drop off point.
- A penalty fee applies if customers refuse to accept any delivery. The fee includes for costs of return to store, restocking and/or storage.

**Claims**

- Mesh & Bar's Scheduler or Representative is to be contacted immediately if any steel is deemed not to comply. All instances will be investigated and checked in a timely and professional manner. **Disputes are to be investigated and resolved prior to pouring concrete.** Mesh & Bar Pty Ltd will not accept any claims if this does not occur.
- Mesh & Bar shall at its own discretion, repair or replace non-compliant goods within 24 hours of being advised.
- Any claim against Mesh & Bar must be in writing, stating full details of the claim within 48 hours of the alleged incident occurring.

All goods and services purchased from the Company and any of its divisions are sold subject to the following terms and conditions of sale ("Terms and Conditions") and these Terms and Conditions shall prevail notwithstanding any other document, terms and conditions and/or anything else except a written agreement signed by the Customer and the Company, except only for such terms as are implied by or under any law and which cannot be excluded.

### **1. Price & Goods and Services Tax ("GST")**

Prices may be altered without notice and all goods will be charged at the price ruling at time of order. Any GST and/or any other Government imposts whatsoever applicable to the supply of goods and/or services will be payable by the Customer.

### **2. Payment**

- (i.) Payment for goods purchased from the Company shall be made on or before delivery or in the case of Customers who have an account with the Company within 30 days from the end of the month of delivery.
- (ii.) The Customer will pay to the Company an administration charge on any amount owing but unpaid at the due date at the rate of 1% per month of the amount overdue.

### **3. Default**

If the Customer defaults in any payment, or if in the opinion of the Company, the Customer is unlikely to be able to meet its liability as it falls due then the Company may at its option:

- (a) require payment forthwith of all amounts owing by the Customer to the Company, whether or not such amounts are then due for payment including administration, collection and legal costs;
- (b) charge full list price for goods supplied without allowing discount.
- (c) terminate any contract or contracts in relation to goods which have not been delivered.

### **4. Reservation of Title**

- (i) Property in any goods supplied by the Company shall remain the sole and absolute property of the Company as legal and equitable owner until the full purchase price is received by the Company.
- (ii) Risk in the goods shall pass to the Customer from the date of delivery to the Customer or its agent. Until payment in full to the Company, the Customer shall hold the goods as bailee for the Company.
- (iii) The Customer irrevocably authorises the Company to repossess goods for which the full purchase price has not been received by the Company, without any notice if the Customer fails to make any payment when it is due or if in the opinion of the Company the payment of any amount in respect of goods supplied by the Company is in jeopardy or the Customer commences to be wound up or is placed under official management or into liquidation or suffers a receiver and/or manager to be appointed in respect of any of its assets. The Customer in consideration of credit being given irrevocably authorises the Company to enter onto any land on which the goods are left and to which the Customer has a right of entry, to enter thereon with vehicles if required (without being responsible for damage thereby caused) and remove the goods.
- (iv) The Customer releases and indemnifies the Company and its servants or agents from all claims for loss or damage caused by the Company or its servants or agents in enforcing or attempting to enforce its rights under this clause.
- (v) When the Company retakes possession of goods pursuant to its rights hereunder the contract for sale between the Company and the Customer is thereby terminated and the Company has the right to resell.
- (vi) Any moneys received by the Customer in payment in part or in full for the goods supplied shall be kept by the Customer for the benefit of the Company and paid to the Company in due course.
- (vii) The Customer will prior to attaching any goods onto any building notify the owner of the building that such goods are attached subject to this reservation of title clause.

### **5. Caveat**

The Customer hereby charges in favour of the Company as security for the Customer's obligations to the Company, all right title and interest in any land held now by the Customer alone or jointly with anyone or acquired by the Customer at any time hereafter. If the Customer defaults in payment of any amount owed to the Company, the Customer specifically authorises the Company to lodge a caveat against any dealings with any such property and appoints the Company to be the Customer's Attorney for this purpose.

### **6. Telephone Orders**

Should there be any discrepancy between the order by telephone as recorded and processed by the Company and later confirmation in writing by the Customer, the Company's record of telephone order shall prevail.

### **7. Cancellations**

Once an order has been accepted by the Company, it can only be cancelled, varied or suspended (whether in whole or in part) upon the following terms and conditions:

- (a) No cancellation, variation or suspension will be effective or recognised unless, and only to the extent, that the Company agrees in writing to such cancellation, variation or suspension;
- (b) The Customer agrees to accept delivery of all goods held by the Company in respect of such order and all goods in transit to or subsequently delivered to the Company for such order;
- (c) The Customer agrees to pay all costs, expenses and liabilities incurred by the Company in consequence of the cancellation, variation or suspension of the order and accepts consequential delay.

**8. Limitation of Liability**

- (i) The Company shall have no liability for discrepancies between estimates it may have prepared of quantities based on plans or other information given by or on behalf of the Customer and quantities actually required. The Customer warrants it has verified and in any event accepts responsibility for the accuracy of quantities ordered as being in accordance with its requirements.
- (ii) The Customer warrants to the Company that it will not rely on representations or advice given by the Company or its employees in connection with the design, installation or use of goods sold and agrees that the Company shall not be liable for the consequences of such representation or advice even if made or given negligently.
- (iii) It is a condition of sale that the descriptions and specifications issued by the Company or other printed literature are given for identification purposes only and (except to the extent that the goods shall comply with the standards set out in such descriptions or specifications) shall not be taken as implying or giving any undertaking as to quality or fitness for any particular purpose whatsoever.
- (iv) The Company shall not be liable for delay in delivery arising from any cause, including negligence on its part. The Customer shall not be relieved from any obligation to accept or pay for goods by reason of delay in delivery or dispatch. In no event shall the Company be responsible for any loss of profits, penalties, expenditure or damages incurred by the Customer arising out of any delay in delivery.
- (v) No claim by the Customer for failure to deliver, short delivery, supply of incorrect goods, faulty goods or pricing errors shall lie unless made in writing within 7 days of delivery or in case of failure to deliver, within 7 days of the first date on which the Company failed to deliver such goods.
- (vi) Return of goods must be preceded by immediate notification in writing covering particulars of goods and reason for return and unless otherwise agreed the goods must be inspected by a Company representative prior to return. The acceptance of any returned goods shall not imply any acceptance by the Company of the Customer's claim. In the event of damage by the Company in transit the Customer is required to give to the Company a written request for replacement together with the delivery docket and evidence that this was endorsed at the time of receipt of goods that the goods were damaged prior to unloading.
- (vii) Any claim, loss and/or damages arising directly or indirectly from the sale or supply or failure to supply or supply of faulty goods by the Company or from the breach whatsoever and howsoever of a contract to sell or supply goods by the Company to the Customer (including any claim arising through negligence or wilful act of the Company) shall be limited to the invoice price of the goods or at the Company's option the replacement of the goods. If the Company offers to replace the goods concerned and upon the Company, replacing or willing to replace the goods concerned the Customer shall be obliged to accept such offer in full satisfaction of and as a complete discharge of any liability of the Company for the claim.
- (viii) (a) The Company is not responsible for any damage whatsoever which may be caused to third parties as a result of any breach of contract by the Company;  
(b) The Customer will indemnify the Company for any claims whatsoever and howsoever made by a third party against the Company for any default of the

Company in relation to or directly or indirectly arising from any contract and/or arrangement made between the Company and the Customer.

**9. Delivery**

- (i.) Where goods are delivered to a particular site the goods will be entirely at the Customer's risk when delivered and if the site is unattended the delivery docket/manifest signed by the cartage contractor or the driver of the Company shall be conclusive evidence of due delivery of the goods.
- (ii.) The Company if requested to enter a property accepts no responsibility for any damage caused by the Company or its employee or agent to the property and goods lying on that property.
- (iii.) Where trucks are held on a site for more than 1 hour additional costs incurred from delays on site or extra labour costs to unload will be to the Customer's account.
- (iv.) A request for deferred delivery of goods already manufactured for the Customer will incur storage charge of 0.5% per week of invoice value.
- (v.) A standard delivery charge as published by the Company from time to time in its price list will apply.
- (vi.) For delivery of lengths over 9 metres please enquire at time of ordering about additional costs.
- (vii.) Unloading of goods shall be the Customer's responsibility and the Company will not be responsible for any damage resulting from the unloading of the goods by the Customer or by anyone on its behalf, or by the Company's employee or agent.
